In reference 1 we submitted Proposed Amendment No. 59 to the Kewaunee Nuclear Power Plant (KNPP) Technical Specifications. The NRC Safety Evaluation (Reference 2) concluded that our proposed amendment was acceptable and Amendment 59 to the Kewaunee Nuclear Power Plant Technical Specifications was issued on January 9, 1985.

Proposed Amendment 59 (Reference 1) included proposed technical specifications on the Control Room Ventilation System. We have been informed by our NRR Project Manager that the Control Room Ventilation technical specifications are being reviewed separately by NRC Region III under TAC# 56410 and therefore were not included in approved Amendment 59.

Subsequent review by NRC Region III has identified an unnecessary redundancy in the existing specifications that could cause confusion. Therefore, we hereby submit three signed and notarized originals and forty (40) copies of Proposed Amendment 59A as a supplement to the original amendment submitted with Reference 1.
