

Reference 1: Letter from D. C. Hintz (WPSC) to H. R. Denton (NRC) dated August 28, 1986

On August 28, 1986 we proposed amendment 77 to the Kewaunee Nuclear Power Plant Technical Specifications and Operating License (Reference 1). Reference 1 requested an additional 30 days to submit our Semiannual Radioactive Effluent Release Reports. Subsequent to the submittal of proposed amendment 77, we discovered that a plant-specific exemption to 10 CFR 50.36a(a)(2) was necessary to fulfill this request. Our current Technical Specifications require this report to be submitted within 60 days after January 1 and July 1 of each year, the same as that required by 10 CFR 50.36a(a)(2).

Further investigation has revealed that numerous other utilities are also having difficulty meeting the requirement of 10 CFR 50.36a(a)(2). Our present intention is to submit a Petition for Rulemaking to amend this rule to allow ninety (90) days to submit the semiannual radioactive release reports.

Please be advised that we are hereby withdrawing proposed amendment 77 to the KNPP Technical Specifications and Operating License. This completes TAC 62748.
