Mr. Gautam also requested that, if available, the system component evaluation worksheets (SCEWs) for master equipment list items should also be included in this letter. Currently, WPSC is in the process of converting from the existing SCEW batch computer system to a new on-line computer system. Unfortunately, the existing SCEW system does not have the capability of printing the specific information requested by Mr. Gautam. While the new system does have this capability, the data entered in this system has not yet been properly reviewed and verified. However, the new on-line computer system will have a properly reviewed data base prior to the NRC EQ audit of March 9-13, 1987. Therefore, the specific information requested will be available at that time. The detailed information provided by the updated master equipment list (Attachment A) should adequately fulfill your pre-audit needs. Should you discover that you require any additional information, please feel free to contact my staff.
