By letter dated February 16, 1987 (Reference 1) Wisconsin Public Service Corporation provided revision 7 to the Kewaunee Nuclear Power Plant (KNPP) Emergency Plan.

Because of an administrative error during the processing of revision 7 to the Emergency Plan we are issuing the attached page correction.

Page 4-21 of the Emergency Plan should be Chart J "Primary System Anomaly" instead of Chart L (cont'd) "Miscellaneous Abnormal Plant Conditions." Since the only change to Chart J in revision 7 was inverting the order in which emergency classification levels are listed, a separate safety evaluation is not necessary.

EMERGENCY CLASSIFICATION CRITERIA	CLASSIFICATION	KNPP INDICATION
Evacuation of Control Room anticipated or required with control of shutdown system established from local stations.	ALERT	Evacuation of Control Room (E-0-06) with control at Dedicated Shutdown and Local Panels.
Loss of containment integrity requiring shutdown by Technical Specifications.	UNUSUAL EVENT	Refer to T.S. Section 3.6 to determine if shutdown is required.
Other plant conditions that warrant increased awareness on the part of plant staff or state and/or local authorities, and requires plant shutdown under Tech. Specifications.	UNUSUAL EVENT	Conditions at the discretion of the Emergency Director or his designated alternate. Examples include cooldown rate exceeding T.S. limits or significant pipe crack found during operation.
