

Record of Revisions

Description of Change

Added revision 8 to the table of revisions to reflect the change made in this revision to the plan.

Safety Evaluation

Since the change is administrative in nature, it does not decrease the effectiveness of the plan.

Page 5-8

Description of Change

Revised the requirements of the Event Operations Director. The plan has been changed to read as follows: "Event Operations Director must hold a SRO license or be a member of senior management who is an engineer trained in nuclear operations."

Safety Evaluation

This revision will allow a Senior Reactor Operator (SRO) licensee who is not actively performing the functions of a senior operator as described in 10 CFR 55.53(e) to hold the position of Event Operations Director (EOD). There is a possibility that candidates for the EOD position may be nonDocument Control Desk July 15, 1987 Page 2

> engineers who have a non-active SRO license, and it is for this small group of individuals that the revision was made. These individuals would be employees with many years of operational experience who are well qualified for the EOD position. The EOD's responsibilities include interfacing with the Shift Supervisor to determine the most appropriate course of action. It is not expected that the EOD will need to relieve the Shift Supervisor. Should relief of the Shift Supervisor be necessary, qualified personnel (i.e., active SRO) will be contacted. Therefore, this change does not decrease the effectiveness of the plan.
