Reference 1 requested Wisconsin Public Service Corporation (WPSC) to provide an answer to four (4) questions with respect to DOE/NRC forms 741 and 742. Our responses follow and are applicable to both forms:

- 1) Was the information transmitted to, and received by, NRC in confidence?
Please give details.

Response:

WPSC cannot establish whether the information was transmitted to NRC in confidence. WPSC does not provide this information to NRC directly; it is provided to DOE as a requirement of our enrichment services contract.

- 2) To the best of your knowledge, is the information currently available in public sources?

Response:

To the best of our knowledge this information is not available in public sources.

- 3) Does your company customarily treat this information, or this type of information, as confidential? Please explain why.

Response:

Contractual information regarding sources of material and services, scope of supply, etc. are generally and customarily held in confidence by WPSC in order to maintain a competitive position with regard to our suppliers.

- 4) Would public disclosure of the information be likely to cause substantial harm to the competitive position of your company? If so how?

Response:

Disclosure of the information could cause substantial harm to the competitive position of WPSC in seeking future sources of supply for uranium and enrichment.

In addition, you requested WPSC to indicate if the information provided in either of these forms has been classified pursuant to an executive order or is considered unclassified safeguards information as defined in 10 CFR 73.21.

Response:

To the best of our knowledge, the information contained on these forms (741 and 742) is not considered unclassified safeguards information as defined in 10 CFR 73.21.

Lastly, you requested that we identify which if any portion of these forms may be publicly disclosed.

Response:

As described above, WPSC would not object to disclosure of any of the information on DOE/NRC forms 741 and 742 with the exception of the country control number which discloses the origin of supply of both enrichment and uranium source material.
