Reference 1 transmitted the results of the Nuclear Regulatory Commission's (NRC) on-site inspection of the Kewaunee Nuclear Power Plant's (KNPP) Environmental Qualification (EQ) Program. Two violations were identified in the inspection report. In accordance with 10 CFR 2.201, Wisconsin Public Service Corporation (WPSC) provided a formal response to the two violations in reference 2.

The purpose of this letter is to inform the NRC of a change in the schedule for implementation of one of the corrective actions described in reference 2. The NRC inspection report (reference 1) stated that various EQ files had not adequately addressed the post-accident accuracy and insulation resistance requirements for EQ equipment. In response, WPSC proposed that formal calculations would be prepared and the appropriate EQ files would be revised. It was anticipated that this process would be completed by September 30, 1987. However, the completion of the formal calculations required more time than was originally anticipated. Currently, the calculations are essentially complete and are being prepared for formal issuance as an auditable EQ file. The subsequent revision of the EQ files that are affected by the formal calculations is now expected to be completed by October 30, 1987. This extension was discussed with the KNPP's resident inspector, R. Nelson, on September 29, 1987.

In summary, the revision of EQ files that was formerly scheduled for completion by September 30, 1987 is now expected to be complete by October 30, 1987. This extension will allow WPSC to ensure a thorough review and revision of the affected EQ files is completed.
