Reason for Change

This sentence describes the qualifications of the personnel conducting audits as discussed in this section of the OQAP Description. The previous wording was consistent with wording in Section 2.2 of ANSI N45.2.23-1978. The new wording was added to specifically identify ANSI N45.2.23-1978 as the basis for auditor qualification. This makes the OQAP Description less vague in this area.

Safety Evaluation

This change makes the OQAP Description more restrictive by identifying a specific ANSI standard as the basis for auditor qualification. Since the previous wording was consistent with ANSI N45.2.23-1978, the new wording does not reduce the level of commitment in the OQAP Description. Therefore, this change does not involve a safety concern.

Page 25

#1 Description of Change

The title changes and reorganization described in section 1.2 of the OQAP are depicted on this figure. In addition, a typographical error in the title of Superintendent-Nuclear Training/Health Physicist has been corrected.

Reason for Change

These changes reflect the current organizational structure of WPSC and correct a typographical error.
