On May 13, 2011, the U.S. Nuclear Regulatory Commission (NRC) and the U.S. Army Corps of Engineers, as a cooperating agency, issued NUREG-1936, "Environmental Impact Statement for the Combined License (COL) for Calvert Cliffs Nuclear Power Plant Unit 3: Final Report" (FEIS). This email is to notify you that the FEIS is publicly available for review. Unfortunately, due to the size of the pdf files the FEIS cannot be sent by email but it is available through the NRC website at <http://www.nrc.gov/reactors/new-reactors/col/calvert-cliffs/documents/nrc-2011.html>. The FEIS is also available for public inspection at the NRC Public Document Room (PDR), located at One White Flint North, 11555 Rockville Pike (First Floor), Rockville, Maryland 20852, or at the Calvert Library, Prince Fredrick and Sothern Branch locations. The FEIS is also available from the NRC's Agencywide Documents Access Management system (ADAMS) which is accessible from the NRC website at www.nrc.gov/reading-rm/adams.html. The FEIS is under the accession numbers ML11129A167 and ML11124A179.
