On May 13, 2011, the U.S. Nuclear Regulatory Commission (NRC) and the U.S. Army Corps of Engineers, as a cooperating agency, issued NUREG-1936, "Environmental Impact Statement for the Combined License (COL) for Calvert Cliffs Nuclear Power Plant Unit 3: Final Report" (FEIS). This email is to notify you that the FEIS is publicly available for review.
