## **Summary of May 11, 2011, Public Meeting Regarding 10 CFR Part 26 Subpart I Implementation Guidance**

On May 11, 2011, the Nuclear Regulatory Commission (NRC) held a public stakeholder meeting regarding implementation guidance for the proposed alternative to the minimum days off (MDO) requirements in 10 CFR Part 26, Subpart I, "Managing Fatigue." The purpose of this meeting was to allow interested stakeholders an opportunity to discuss with the NRC implementation guidance concepts and specific details for implementing cumulative fatigue provisions that will be based on a maximum 54 hours per week rolling average. This was the second meeting on this topic.

The meeting was noticed on April 29, 2011. The notice is available electronically at the NRC's Electronic Reading Room at <http://www.nrc.gov/reading-rm/adams/web-based.html> where the public can access the text and image files of NRC's public documents in the NRC's Agencywide Document Access and Management System (ADAMS). ### **1. Opening Remarks**

The meeting began with opening remarks. The NRC staff stated that the purpose of the meeting was to discuss the guidance that will accompany the recently proposed rule regarding an alternative to the MDO requirements in Part 26.<sup>1</sup> The proposed alternative is a 54-hour weekly limit, averaged over a rolling 6-week (or shorter) period. This public meeting followed-up on the discussion during the April 27, 2011, public meeting on the same topic. As a basis for this meeting NEI had submitted a revised guidance document based on the outcomes of the April 27, 2011 meeting.

### **2. NRC Comments and Questions on the Revised Guidance Document**

Following a brief presentation on the revised guidance document by NEI representatives, the NRC staff commented on the guidance and asked clarifying questions. These comments and questions focused on the following topics.

#### **Terminology**

The NRC staff suggested that certain terminology used throughout the guidance document needs clarification.

### Definition of Rolling Period

The NRC staff identified an inconsistency between the proposed rule and the proposed guidance with regard to the allowable rolling (incrementing) period. The staff also suggested that the term “calendar days” needs to be defined more explicitly.

### Partial Averaging Periods

The NRC staff asked questions regarding a perceived inconsistency between the proposed rule and the proposed guidance with regard to individuals who begin covered work in the middle of an averaging period.

### **3. Next Steps**

At the conclusion of the meeting, the NRC staff stated that the overall approach in the guidance is generally acceptable. NEI agreed to revise the guidance to address the comments and questions received during the meeting. Once completed, NEI will submit the revised document to the NRC staff for review. The NRC staff suggested that another public meeting should be held on the revised draft guidance before the close of the proposed rule’s comment period on May 26, 2011.
