Dear Mr. Vincent:

This refers to your license amendment request. Enclosed with this letter is the amended license adding Dr. King as an authorized user. Please note that, in accordance with 10 CFR 35.50(c)(2), Dr. King must first be an authorized user identified on your NRC license prior to being named as your Radiation Safety Officer (RSO). We understand from discussions with your consultant, Mr. Stoneberg today, that Dr. Anton will continue the duties of RSO and that a separate amendment request to name Dr. King will be submitted at a later date.

In addition, it was noted that your letterhead refers to your name as Braxton County Memorial Hospital instead of Braxton County Hospital. If your name has changed, please review the guidance in NUREG-1556, Volume 15, Appendix F, and submit the requested information to change your licensed name immediately.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
