Because of events occurring at the Kewaunee Nuclear Power Plant which have resulted in the temporary cold shutdown of that plant, the one remaining "Category A" requirement will be installed at Kewaunee prior to January 31, 1980. The performance of that installation is consistent with the position previously taken by the operator of the plant namely, that it would be undertaken during any shutdown of sufficient duration.

The Licensees are still of the opinion that the action proposed in the Order to Show Cause signed by you on January 2, 1980, was unjustified and subject to modification for the reasons stated in the Answer to the Order to Show Cause previously filed. However, because there are no longer any outstanding unperformed requirements, we do not believe that there remains any issue upon which a hearing can be held at this time. Accordingly, in light of the foregoing, to the extent the previously filed answer requests a hearing, said request is hereby withdrawn.
