Report on On-Site Property Damage Insurance

This letter is sent in accordance with the requirements of 10 CFR 50.54(w)(2) which requires that all licensees report on April 1 of each year to the Commission their present levels of on-site property damage insurance or financial protection.

The amount of on-site primary property damage insurance which WPSC and its partners currently maintains with ANI/MAELU on the Kewaunee Nuclear Power Plant is \$500,000,000, plus an additional amount up to \$400,000,000 for damage in excess of \$500,000,000.

In addition, we also have NEIL II excess property insurance in the amount of \$1,250,000,000.

To our knowledge, this amount of insurance coverage complies with the requirements of 10 CFR 50.54(w)(1).
