This letter is sent in accordance with the requirements of 10 CFR 50.54(w)(2) which requires that all licensees report on April 1 of each year to the Commission their present levels of on-site property damage insurance or financial protection.

The amount of on-site primary property damage insurance which WPSC and the KNPP joint owners currently maintain with ANI/MAELU on the Kewaunee Nuclear Power Plant is \$500,000,000.

In addition, we also have NEIL II excess property insurance in the amount of \$1,400,000,000 and an additional \$100,000,000 with NEIL III.

To our knowledge, this amount of insurance coverage complies with the requirements of 10 CFR 50.54(w)(1).
