NOTICE OF REQUEST FOR EXTENSION IN SUBMITTING EVALUATIONS

As required by 10 CFR § 50.46(a), certain licensees and applicants must submit, consistent with 10 CFR § 50.46(a) (2) (ii), an evaluation of the performance of emergency core cooling systems (ECCS) by August 5, 1974, unless an extension thereto has been obtained from the Director of Regulation pursuant to §50.46(a) (2) (iii). As required by § 50.46(a) (2) (iii), notice is hereby given that the Director of Regulation has received and is considering a request from the Wisconsin Public Service Corporation for a thirty-one (31) day extension of the submittal date for the Kewaunee Nuclear Power Plant ECCS evaluation.

The request for extension is signed under oath and states the reasons why the evaluation is not complete and the minimum time necessary to complete it. The licensees are authorized by Facility Operating License No. DPR-43 to operate the facility located in Kewaunee County, Wisconsin at steady state power levels up to 1650 megawatts thermal.

Wisconsin Public Service Corporation states that the reactor vendor will provide the evaluation to the Wisconsin Public Service Corporation no earlier than July 19, 1974, and that, upon receipt of the completed ECCS evaluation, it must evaluate within its own organization the implications and technical specification reflections. The licensee further states that the Company's Nuclear Safety and Audit Committee must review the final submittal and procedures will have to be changed as required. Wisconsin Public Service Corporation states that a 31-day extension is required to make this submittal.


The extension may be granted upon a finding that good cause has been shown for granting of the extension. The Director of Regulation will consider and issue a determination with respect to the request for extension as required by 10 CFR § 50.46(a) (2) (iii). In that connection, the Director of Regulation invites the submission of views and comments by any interested persons. Such views and comments should be submitted in writing, addressed to the Director of Licensing, Regulation, U.S. Atomic Energy Commission, Washington, D. C. 20545 not later than JUL 25 1974.
