Based on the review of the Comanche Peak Chapter 8 safety evaluation, I have updated the status of the questions. See attached.

#### Open Items

RAI 2576, Question 08.01-2 (Open Item 08.01-1) – As stated in the safety evaluation “The staff reviewed the applicant’s response and finds that the applicant has not stated whether or not the sharing of structures, systems, and components important to safety that are shared among nuclear power units will not significantly impair their ability to perform their safety functions, including in the event of an accident in one unit, or an orderly shutdown and cooldown of the remaining units”.

RAI 5116, Question 08.02-30 (Open Item 08.02-1) – Inconsistency between the DCD chapter 15 language related to anti-monitoring protective relaying for main generator output breaker.
