Dear Ms. Cook:

We have received Amendment No. 15 to our Materials License 35-17054-01. The requested change was in our named Radiation Safety Officer. That change was implemented as requested. However, new requirements were added concerning items 8.A and 8.B which cause us major concern. In fact, the stated requirement of 396 millicuries total for possession at any one time for Am-241 brings us out of compliance with the number of instruments we have possessed for many years.

The issue of total amount of licensed material was discussed with NRC inspector Latischa Hanson during an inspection of our facilities on August 9, 2010. Ms. Hanson indicated that the next amendment or renewal of our license would most likely include the addition of a numerical value for "total amount of licensed material to be possessed" on our license, but that the value would be sufficient to cover our existing number of gauges plus a reasonable extension to allow procurement of a few additional instruments. The amendment issued does not provide for that quantity.

We currently have twenty-two (22) nuclear density gauges, each with between 7.6 and 8.6 miC of Cs-137 and 40 miC of AM-241, as indicated by the original measurements for the sealed sources. Under current conditions, we anticipate that we would likely need to procure up to four (4) additional instruments by the October 31, 2014, expiration date of our license.

We request that you provide formal acknowledgment that we are authorized to possess the instruments currently in our possession. We also request that you revise Amendment No. 15 to our license to allow up to 224 miC of Cs-137 and up to 1040 miC of Am-241, in sealed sources for Troxler Electronic Laboratories, Inc. nuclear density gauges models 3411B, 3430, 3440, and 3450.
