On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to comments you submitted in response to the notice published in the Federal Register for license applications for the import and export of radioactive waste (75 FR 74104 and 74107; November 30, 2010).

After review of your comments, consultations with the Executive Branch, the State of Tennessee and the Southeast Low-Level Waste Commission, the NRC has determined that the import and export of this material to and from Germany: (1) will not be inimical to the common defense and security; (2) will not constitute an unreasonable risk to the public health and safety; (3) satisfies (to the extent applicable) the environmental requirements of Part 51; and (4) has had an appropriate facility agree to accept the waste for management or disposal. In this case, the facility accepting the waste for disposal is in Germany hence the need for the export license.

Enclosed is the Commission Order that explains the bases for denying the hearing requests and petition to intervene. The Order also directs NRC staff to issue the import and export licenses.
