

Enclosure 1 contains several pages which should be inserted into your Updated Safety Analysis Report (USAR) for the Kewaunee Nuclear Power Plant. Due to two-sided copying errors, you may need to replace USAR Tables 4.1-9 and 5.4-3, which could have been inadvertently discarded when you updated your USAR. Additionally, the "Current Status USAR Pages - Indices" located in the front of your USAR should be replaced in its entirety with the enclosed revised pages (USAR Indices Pages CS0-1 through CSH-1). These pages were revised to correct minor clerical errors. It should be noted that the Current Status Pages lists the complete contents of the USAR, including the effective date of the pages. Therefore, if necessary, this list can be used to verify the contents of your USAR and confirm that it contains current and correct pages, sections, tables, and figures.

Attachment 1 of Reference 1 contained descriptions and summaries of the safety evaluations for changes, tests, and experiments associated with the procedures and facility described in the USAR, which fulfilled the reporting requirements pursuant to 10 CFR 50.59. Enclosure 2 of this letter contains corrections/clarifications relative to two of the summaries. These summaries, along with this letter, should be retained with the original submittal in Reference 1.
