Pursuant to 10 CFR 50.71(e), we are submitting ten copies of Revision 14 to the Updated Safety Analysis Report (USAR) for the Kewaunee Nuclear Power Plant (KNPP). This revision updates information in the USAR through May 14, 1997, although some information may reflect more recent changes. It should be noted this revision does not reflect changes which may be necessary to address several outstanding USAR discrepancies which were identified earlier this year in a self-assessment of the maintenance of our licensing basis (Reference 1). Our preliminary investigation of these issues has concluded that plant safety is not affected. These issues have been documented and their progress/status is being tracked by our 10 CFR 50, Appendix B, corrective action program (KAP).

This submittal also fulfills the reporting requirement associated with facility and procedure changes made pursuant to 10 CFR 50.59, and includes information for changes implemented and completed prior to May 14, 1997, and not previously reported. This requirement was formerly satisfied by the KNPP Annual Operating Report.

Attachment 1 to this letter contains the descriptions and summaries of the safety evaluations for changes, tests, and experiments associated with the procedures and facility described in the USAR, including those changes not resulting in a revision to the USAR. USAR revisions resulting from these changes are identified in the attachment. Also included are discussions of other USAR revisions due to administrative and editorial changes, and minor corrections and clarifications; many of which were a result of our continuing licensing basis self-assessment efforts.
