
## Gentlemen:

This letter transmits a change in Wolf Creek Nuclear Operating Corporation's (WCNOC) updated list of Owners, Officers, Directors and Executive Personnel (OODEP) to support the NRC's making a Foreign Ownership, Control or Influence (FOCI) determination and a Facility Security Clearance determination with regard to WCNOC and Wolf Creek Generating Station.

The reference transmitted separate, updated, confidential OODEP lists for WCNOC and its three owner companies (Kansas Gas and Electric Company [KGE], Kansas City Power & Light Company [KCPL] and Kansas Electric Power Cooperative, Inc. [KEPCo]) as well as for KGE's ultimate parent company, Westar Energy, Inc., and KCPL's ultimate parent company, Great Plains Energy Incorporated [GPE]. By this letter, we are transmitting recent officer changes for WCNOC. In accordance with 10 CFR 95.17(a)(1), WCNOC is providing the NRC with notice of these changes in OODEP.

Specifically, this letter is to advise the NRC that:

• Richard P. Clemens replaced Terry J. Garrett as Vice President Engineering for WCNOC, effective May 26, 2011.



 Terry J. Garrett's title changed to Vice President on Loan for WCNOC, effective May 26, 2011. The NRC already has Mr. Garrett's personal information, and thus it is not included with this letter.

The enclosed OODEP information contains personal confidential information. Therefore, WCNOC requests that the NRC treat the enclosure as exempt from public disclosure under 10 CRF 2.390(a)(6) as "Personal and medical files and similar files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy."
