Subject: Oyster Creek Nuclear Generating Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan, (Revision 11)

In accordance with 10 CFR 50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting Revision 11 to the Oyster Creek Nuclear Generating Station (OCNGS) Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan, (Security Plan). The changes to the OCNGS Security Plan were implemented on May 05, 2011. In accordance with 10 CFR 50.54(p)(2), EGC is submitting this change within 60 days of implementation (i.e., no later than July 04, 2011).

The OCNGS Security Plan has been revised to address intrusion detection at a specific point which is not supported by the site fence/Perimeter Intrusion Detection System. Details of these changes are classified as safeguards information.

EGC has concluded that the changes do not decrease the safeguards effectiveness of the OCNGS Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.
