SYNOPSIS

This investigation was initiated by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI), Region II (RII), on February 16, 2011, to determine whether a Farley Nuclear Plant (Farley) security officer was willfully inattentive while on duty and whether another security officer witnessed the inattentiveness and willfully failed to report the violation.

Based on the evidence developed, this investigation did not substantiate the allegations that a Farley security officer was willfully inattentive while on duty and that another officer witnessed the inattentiveness willfully failed to report the violation.
