I want to get into the administrative record and to inform the other recipients of this email, the corrections in regard to two errors in the referenced letter, which you and I discussed yesterday.

1) Page 8, paragraph #9. Regulatory Division received the report from Engineering Division on June 23, 2011. The report was dated June 14, 2011.

2) Page 22, next to last paragraph should have referenced not the FEIS, but the date of the letter itself: "If a complete response to this letter is not received from you within 30 days after the date of this letter, the application will either be considered withdrawn or a final decision will be made.
