This letter transmits WCAP-12985, Rev. 1 (proprietary), and WCAP-12986, Rev. 1 (non-proprietary), versions of "Kewaunee Steam Generator Tube Plugging Criteria for ODSCC at Tube Support Plates," dated January 1993. These WCAPs are being submitted for NRC staff review in order to support a proposed amendment (PA) request for steam generator tube support plate alternate repair criteria. The PA will be transmitted to the NRC staff for consideration in the very near future following review by the Kewaunee Plant Operating Review Committee.


