Reference: 1) Letter from K. H. Evers (WPSC) to Document Control Desk (NRC) dated September 30, 1991

This letter provides notification of temporary organizational changes at Wisconsin Public Service Corporation (WPSC). The Assistant Manager - Plant Operations and the Superintendent - Nuclear Engineering Control have been temporarily reassigned for the next six to nine months.

During this period, the Reactor Engineering group will report directly to the Manager - Kewaunee Plant and the Superintendent - Plant Operations will assume the responsibilities of the Operations group activities. The Superintendent - Plant Operations had previously assumed the responsibilities of the Assistant Manager - Plant Operations on a temporary basis for several months in 1991 and 1992, as indicated in Reference 1. The Superintendent - Plant Operations has excellent technical qualifications, has been in the operations department since initial plant start-up, and has earned a significant number of credits from the University of Maryland science degree program. WPSC has reviewed the KNPP Technical Specifications for plant staff qualifications to verify that we continue to meet all requirements of the Assistant Manager - Plant Operations position.

Personnel previously reporting to the Superintendent - Nuclear Engineering Control have been temporarily reassigned to several different areas. The responsibility for vendor services and budget control has been delegated to the Supervisor - Nuclear Services. Records management and the coordination of the development and implementation of the nuclear configuration management program have been delegated to the Superintendent - Nuclear Project Management. Drawing control and design document control have been delegated to the Superintendent - Nuclear Engineering Support, and the independent technical review program is now directly the responsibility of the Manager - Nuclear Engineering.

WPSC has concluded that these changes are administrative in nature and do not involve a safety concern. These changes affect the Operational Quality Assurance Program Description (OQAPD); however, as the changes are only temporary, WPSC does not intend to revise this document.
