

 The purpose of this contract modification is to provide incremental funding in the amount of \$271,000.00, thereby increasing the obligated amount from \$3,065,173.58 to \$3,336,173.58. Accordingly, Section B.3 CONSIDERATION AND OBLIGATION- COST PLUS FIXED FEE - ALTERNATE I (JUN 1991), paragraph (g) is revised to the following:  
 "(g) The amount currently obligated by the Government with respect to this contract is \$3,336,173.58, of which the sum of \$3,092,279.58 represents the estimated reimbursable costs, and of which \$243,894.00 represents the fixed fee."
