This is to inform you that we have received NRC Inspection Report 92021, dated October 28, 1992. This inspection report discussed the results of the Kewaunee Nuclear Power Plant's (KNPP) 1992 Annual Emergency Exercise. There were no violations of NRC requirements, however, several exercise weaknesses were identified. To discuss the identified weaknesses and concerns the NRC staff requested a management meeting with senior members of our staff. In addition, we were requested to provide a written response addressing each of the exercise weakness within 30 days of receipt of the inspection report.

As discussed with Mr. S. Orth of your staff, this management meeting has been scheduled for December 2, 1992. We would like to delay the submittal of our written response until after this management meeting. This will give us an opportunity to ensure that we fully address all of the staff's concerns in our response. If this delay is acceptable, we will provide our written response within 30 days of the management meeting.
