Dear Mr. Flagor:

Enclosed is Amendment No. 01 to your NRC Material License No. 04-24888-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In reviewing and preparing this amendment it became apparent that several pieces of information needed to complete the review were missing. I contacted you via electronic mail and by telephone on May 23, 2011, and the missing information was obtained.

For future reference, please be sure to use the guidance in NUREG 1556, Vol. 2, "Consolidated Guidance About Materials Licenses: Program-Specific Guidance About Industrial Radiography Licenses," to prepare all of your licensing correspondence and ensure its completeness and accuracy.

Section 8.5.1, Item 5 in this guidance document describes the information needed for an amendment such as the one just completed. The response from you, the licensee, must include:

"Response from Applicant:

- * Identify each radionuclide that will be used. Identify the manufacturer (or distributor) and model number of each sealed source, source assembly, exposure device, and/or source changer to be possessed. Identify any depleted uranium that is used as shielding material.**
- * Confirm that each sealed source, device, and source/device combination possessed is registered as an approved sealed source or device by NRC or an Agreement State and will be possessed and used in accordance with the conditions specified in the registration certificate.**
- * Confirm that associated equipment is compatible with the exposure devices, source changers, and sealed sources containing byproduct material.**

The enclosed document contains sensitive security-related information.
When separated from this cover letter this letter is uncontrolled.

*** Identify by radioisotope and manufacturer (or distributor) and model number any other sealed sources containing byproduct material (i.e., any source that will not be used for performing radiography).**

*** Confirm that all radiographic exposure devices, source assemblies or sealed sources, and all associated equipment which meet the requirements specified in 10 CFR 34.20 will be used in radiographic operations."**

In addition, you must provide the maximum activity per source, maximum number of sources and total activity to be possessed, which is a change that has come about since this guidance document was published in August 1998.

Please also be reminded of the provisions in 10 CFR 30.9(a), "Completeness and accuracy of information,"..."(a) Information provided to the Commission by an applicant for a license or by a licensee or information required by statute or by the Commission's regulations, orders, or license conditions to be maintained by the applicant or the licensee shall be complete and accurate in all material respects."

Failure to provide complete and accurate information in licensing correspondence can result in processing delays. Your assistance is greatly appreciated.

Please note that when we discussed how many sealed sources you would need, as I told you, I doubled that amount in order to ensure that you could have the same number of sources available at the same time for replacement purposes, in a "worst case scenario," which is unlikely but reasonable to accommodate your business needs.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.


