On May 26, 2011, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees and the NRC staff discussed the list of currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

The NRC staff discussed the status of FAQ 08-0053, which deals with Kerite cable categorization. The staff stated that the final test report was not ready for publication, and that they expected to issue it to the public in July.

The NRC staff and licensees discussed comments on FAQ 10-0059, which deals with the NFPA 805 Monitoring Program. The NRC staff committed to provide written comments to the licensees prior to the next meeting.

Participants agreed that the next FAQ meeting would take place on June 30, 2011, via teleconferencing.
