In accordance with the requirements of 10 CFR 50.73, "Licensee Event Report System," the attached Licensee Event Report (LER) for reportable occurrence 93-011-02 is being submitted.

The new commitments contained in this LER are scheduled to be completed during the 1995 refueling outage and are as follows: 1) AFW-10B will be inspected and polished/repaired (if necessary), 2) AFW-10B will be dynamically tested after the inspection and repair work to determine if it will operate under all design basis conditions, 3) AFW-10A will be dynamically tested to trend the dynamic test data, 4) A periodic inspection schedule for AFW-10A and AFW-10B will be established to ensure long term acceptable performance, and 5) The procedure changes made as intermediate term corrective actions will be reviewed to determine if they are still appropriate.
