In accordance with the requirements of 10 CFR 50.54(a)(3), the reference submitted the current description (Revision 17) of Wisconsin Public Service Corporation's (WPSC) Operational Quality Assurance Program. Following recent discussions with the NRC staff, WPSC has agreed to clarify two changes that were previously provided with Revision 17.

Specifically, page 7 of the OQAP description has now been modified to reflect the Nuclear Training area having responsibility for the accredited training programs. And page 23 has been revised to reflect that measures to control audit findings shall be established in Quality Procedures and appropriate directives. These changes ensure no reduction in commitments from the previous revision (Revision 16) of the OQAP description.
