Region III Decommissioning staff facilitated a telephone conference call and discussion with representatives from the State of Michigan - DEQ, the Trustee and Trustee Legal Rep., and EnergySolutions regarding their status of actions to complete in order to allow EnergySolutions to mobilize and complete work at the site.

- Specific topics discussed:**
1. Mixed chemical waste stored in SU-1
 - a. To allow FSSs to be performed, the chemical waste can be moved about to not impede surface scans if it is still on site
 - b. Region V, Federal EPA will remove the waste once a schedule is established
 2. EnergySolutions will not revise their work plan, but will instead draft a stand-alone procedure for the water removal from the trenches and discharge into Bush Creek.

- ACTION REQUIRED**
- 1) Trustee is waiting for a schedule from Region V, Federal EPA, regarding the removal of mixed chemical waste that is stored on SU-1.
 - 2) EnergySolutions is drafting a stand-alone procedure for the water removal from the trenches, and will submit to the NRC for their review by Friday, July 1, 2011.
