The purpose of this modification is to provide incremental funding in the amount of \$57,000.00, thereby increasing the obligated amount from \$217,810.00 to \$274,810.00. Accordingly, the following is hereby modified:

Section B.2, CONSIDERATION AND OBLIGATION - LABOR HOUR CONTRACT, paragraph (b) is revised as follows:

"(b) The amount currently obligated by the Government with respect to this contract is \$274,810.00. The contractor shall not exceed this obligated amount."

All other terms and conditions remain unchanged, including the ceiling amount of \$295,776.00 and the period of Performance of December 16, 2008 through December 15, 2011.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
