The purpose of this modification is to add incremental funding in the amount of \$80,000.00, therefore section "A.5 CONSIDERATION AND OBLIGATION-LABOR HOURS" is revised as follows:

A.5 CONSIDERATION AND OBLIGATION-LABOR HOURS

- (a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$361,878.00**.
- (b) The amount presently obligated with respect to this contract is **\$190,000.00**. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract.
