Effective with the date of this contract Article B.5 is modified as follows:

B.5 CONSIDERATION AND OBLIGATION-- HYBRID TYPE CONTRACT

1) INDEFINITE QUANTITY LINE ITEMS:

(d) The amount presently obligated with respect to this contract for line items 1001 – 1007 is \$288,971.03. The Contracting Officer or Project Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

2) COST-REIMBURSEMENT LINE ITEMS:

(b) The total estimated cost to the Government of the cost-reimbursement line items (CLIN 1008) for full performance under this contract is \$5,000.00.
