NEI 03-12 was developed to assist licensees with compliance with the Commission's Regulation 10 CFR 73.55, which requires licensees to provide physical protection of nuclear power reactors, against radiological sabotage. NEI 03-12 has been revised through the combined efforts of the NRC, NEI, and key industry personnel, in order to address regulatory issues that have the potential to impact site security licensing documents.
