Reference (1) outlined the Lessons Learned Task Force recommendations with schedule requirements. Reference (2) described the existing Prairie Island systems as appropriate and planned implementation dates. In some cases, the long term implementation dates were based on refueling outage dates rather than the fixed date of January 1, 1981. The Unit 2 outage date is tentatively scheduled during January 1981.

Reference (3) requested a detailed justification for any possible delays that might occur in meeting the January 1, 1980 implementation dates. Enclosure (1) is an updated version of the original Reference (2) response with revised schedule dates and justification as appropriate.

The expected implementation dates are based upon timely receipt of NRC guidance in some areas, availability of equipment from suppliers, and other factors not under full control of the licensee. NSP will keep the NRC informed of potential delays to the schedules contained herein as they become apparent.
