

Maine Yankee Emergency Plan

Dear Sir:

Pursuant to 10 CFR 50.54 (q), please find enclosed the appropriate number of copies (ten (10) copies for NRR, three (3) copies for Region I, I & E) of revised pages to Reference (b).

These changes reflect changes to the distribution of the Public Emergency Alerting System (PEAS) equipment that we initially described to you in Reference (c).

As previously stated in Reference (c), the town of Edgecomb has steadfastly refused to accept a gift of PEAS equipment from Maine Yankee. Maine Yankee has, however, installed a 50 HP fixed siren in the town that should adequately provide the alert signal to the inhabitants of the town. In addition, the NOAA weather radio transmitter with tone alert capability blankets the entire area, Edgecomb included, with a clear signal.

In July 1981, Maine Yankee wrote to Edgecomb officials indicating that we would be willing to discuss the matter should the town reconsider its rejection of our offer. We have had no response.

In light of Edgecomb's unwillingness to accept any PEAS equipment, the enclosed changes to Appendix 3 of Reference (c) reflect the fact that pager/monitors and mobile sirens are not part of the PEAS system in Edgecomb.

Also, one additional mobile siren has also been provided to each of the communities of Newcastle, Phippsburg, and Boothbay.

These changes do not degrade the level of protection for the public health and safety. Further, these changes do not decrease the effectiveness of the plan therefore prior Commission approval is not required.

We trust this information is satisfactory.
