

Comments on NRC Inspection Manual Chapter 1248

1. OJT-2 (Radiography), Page A-62: Recommend you add the Sealed Source and Device Registration (SSD) database, Security Orders (10 CFR Part 37) and National Source Tracking System (NSTS) to the reference section as a license reviewer should use these during the licensing process.
2. OJT-3 (Measuring Systems), Page A-64: Recommend you add SSD, Security Orders (10 CFR Part 37) and NSTS to the reference section as a license reviewer should use these during the licensing process.
3. OJT-3 (Measuring Systems), Page A-65: Recommend changing the requirement of completing one new application and one amendment for each of the codes to one new application and one amendment of any of the following codes (3120, 3121, 3122, 3123, 3124) and one new application and one amendment of any of the following codes (3510, 3511, 3520, 3521).
4. OJT-4 (Well Logging), Page A-67: Recommend you add the SSD database to the reference section.
5. OJT-4 (Well Logging), Page A-68: Recommend you change the statement in Task 1 from “for each of following program codes” to “for any of the following program codes.”
6. OJT-5 (Broad Scope), Page A-70: Recommend you include 10 CFR Part 33, SSD, Security Orders (10 CFR Part 37) and NSTS to the reference section.
7. OJT-5 (Broad Scope), Page A-71: Recommend you change the task assignment in number 1 to one new application and one amendment for any of the following codes: (1100, 1110, 1120), one new application and one amendment for any of the following codes: (3211, 3212, 3213) and one new application and one amendment for any of the following codes: (3610, 3611, 3612, 3613).
8. OJT-7 (Medical), Page A-75: Recommend you add the SSD to the references.
9. OJT-7 (Medical), Page A-76: Recommend you change the task assignment in number 1 from one new application and one amendment for each of the following codes (2120, 2121, 2200, 2201) to one new application and one amendment for any of the following codes: (2120, 2121), one new application and one amendment for any of the following codes: (2200, 2201).
10. OJT-8 (Other Medical), Page A-78: Recommend you add SSD, Security Orders (10 CFR Part 37) and NSTS to the reference section.
11. OJT-8 (Other Medical), Page A-79: Recommend you delete code 2231 from the Task 1 requirement.
12. OJT-9 (Broad Scope Medical), Page A-80: Recommend you add 10 CFR Part 33, SSD, Security Orders (10 CFR Part 37) and NSTS to the reference section.

15.
