Please provide access and copies of public records that relate to:

1. The **most recent** FOIA request from January 2011 to the present— from anyone other than me – for information related to unclaimed, uncashed, or undelivered check(s)/warrant(s) ***where the information related to unclaimed, uncashed, or undelivered check(s)/warrant(s) was located, and then actually provided to the Requestor in response.***

The information actually provided in response may have included the actual the Limited Payability Cancellation Report(s), a list of deposits into Treasury Account 20x6133, or a list of check(s)/warrant(s).

Please include:

- An electronic copy of correspondence(s) between your entity and the requestor.
- An electronic copy of the actual records provided in response to the request which related to unclaimed, uncashed, or undelivered check(s)/warrant(s). For example, the list of checks provided in response to the request.

NOTE: I am not interested in receiving records where the request did not result in records actually being provided to the requestor.

2. In the alternative, ***if the above records do not exist or cannot be found***, please provide the most current information related to unclaimed, uncashed, or undelivered check(s)/warrant(s) ***such as*** Limited Payability Cancellation Report(s), or a list of deposits into Treasury Account 20x6133.

In lieu of examining individual records, I do agree to an existing list/report, or a compilation, if it is easier or more cost effective. If these fees and costs should exceed \$25, please advise me before complying with this request. If some of this request is exempt from release, please furnish me with those portions reasonably segregable.

To the extent that any of the requested records may be subject to multi-tracked processing, to the extent that any one of the requested records may be more readily accessible than the others, I request the response be addressed in such a manner as to expedite production of as many as the responsive documents, as is possible.

If some of this request is exempt from release, please delete or excise only that portion of the record to which an exemption applies and release the remainder of the record, and identify with reasonable particularity the volume and the subject matter of any withheld records and cite the specific Code section that authorizes the withholding of the records.

Finally, [REDACTED] postal mail. As an accommodation, I ask that you please communicate with me and provide the records electronically by email at [REDACTED]. And, we'll help the environment by saving a few trees.
