Dear Mr. Cruess:

This refers to your NRC license listed above. Item 8 of the license is not written in correct form in accordance with current NRC policy. Therefore, we have administratively amended your license to correct the information in Item 8 of the license. The maximum possession limits in item 8 are based on the information that you had provided during the NRC inspection of your licensed activities. Condition 17 that appears in the previous amendment to your license is deleted because it is not applicable, and Condition 11 is revised in accordance with current NRC policy. Enclosed with this letter is the amended license.

You must request and receive an amendment to your license prior to acquiring licensed material in excess of the limits specified in Item 8 of the license.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
