This is in reference to your letter dated May 18, 2011 requesting amendment to Nuclear Regulatory Commission License No. 49-26846-01. In order to continue our review, we need the following additional information:

1. Please compare the list of isotopes you provided to be added on the license with the exempt quantity or exempt concentration tables found in 10 CFR 30.71 & 30.70, respectively. It appears that some of these sources may be obtained as exempt concentrations. The following link shows the isotopes and their exempt quantity found in 10 CFR 30.71 <http://www.nrc.gov/reading-rm/doc-collections/cfr/part030/part030-0071.html>. If you will obtain the sources in liquid form please compare to the exempt concentration table found in the following link <http://www.nrc.gov/reading-rm/doc-collections/cfr/part030/part030-0070.html>.
2. Please provide documentation showing how you disposed of the Gadolinium-152 and Gadolinium-148.

We will continue our review upon receipt of this information. Please reply to my attention and refer to Mail Control No. 575236. If you reply via email, please attach a signed letter in PDF format or you may fax your response to (817) 860-8263. If we do not receive a reply from you by August 7, 2011, we will assume that you do not wish to pursue your application.

In response to your email dated July 7, 2011, we have decided to go ahead and leave the exempt quantity isotopes on our license and would like to go ahead and add what was listed on our latest amendment.

Addressing the reason for removing Gadolinium-152 and Gadolinium-148, we have decided not to procure, nor have we ever procured, either one of these isotopes. This abates the issue of disposal for these two isotopes.
