Dear Mr. Higgins:

This refers to your letters dated June 20, and June 29, 2011, requesting an amendment to your NRC license listed above. Enclosed with this letter is the amended license.

Pursuant to our telephone discussion of July 12, 2011, the amended license includes revised maximum possession limits of the radioisotopes authorized on the license (Item 8). Additionally, Condition 11 of the license is revised in accordance with current NRC policy, and Conditions 13, and 19 that appear in prior amendments to your license are deleted from the amended license because they are not applicable. As I explained to you during our telephone discussion, your NRC license is applicable only in areas where the NRC maintains jurisdiction for regulating radioactive materials.

You must request and receive an amendment to your license prior to using licensed material in excess of the limits specified in Item 8 of the license.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
