SRP 13.06: RESPONSE TO RAI LETTER 55

On February 8, 2011, the NRC requested additional information to support the review of certain portions of the North Anna Unit 3 Combined License Application (COLA). The letter contained twenty-five Request for Additional Information (RAI) questions. The responses to thirteen of the RAIs were provided in a letter dated March 22, 2011 (Serial No. NA3-11-005R). The responses to ten of the remaining RAIs were provided in a letter dated May 26, 2011 (Serial No. NA3-11-005RB). As discussed with the NRC staff, the responses to the remaining two RAIs, 13.06-22 and 13.06-33, will be provided to the NRC by August 5, 2011.

In the response to RAI question 13.06-26 and also referenced in the responses to RAIs 13.06-15 and 13.06-16 (Serial No. NA3-11-005R), Dominion committed to create a Physical Security Plan (PSP) for the North Anna units, separate from the Dominion operating fleet PSP to aid in the review of the PSP for the COLA. The North Anna Power Station Units 1 and 2, and Unit 3 Combined Operating License Application (COLA) Security Plan, Training and Qualification Plan, Safeguards Contingency Plan, and Independent Spent Fuel Storage Installation Security Program (COLA PSP), Revision 3 provides information applicable to North Anna Units 1, 2 and 3 and is provided in Enclosure 1.

The COLA PSP was created by copying information from the operating fleet PSP applicable to North Anna Units 1 and 2 and then adding information applicable to North Anna Unit 3. The COLA PSP is submitted as part of the license application to provide assurance of physical protection of North Anna Unit 3 in accordance with applicable




