STP comments are provided below, related to Chapters 5, 6 and 10:

**(Ch 5)**: We agree that RCIC items #70, 71 and 89 were closed based on the 6/21 discussion; however, STP left with with the understanding that a follow up ACRS action item associated with RCIC would need to be addressed: "How long to reach 77C in the suppression pool during SBO?"

(Ch 6/LTC): Item #47a states "Provide downstream effects test procedure to ACRS" -- we believe that this issue has been resolved for COLA review based on STP 3&4 commitment COM 6C-2 to provide the detailed test procedure to the NRC at least six months prior to performing the test (letter U7-C-NINA-NRC-110078, dated 6/8/11).

(Ch 10): Item #59 states "Closed-Post COL turbine missile analysis to be provided to ACRS" -- we agree that this issue should be closed for COLA review; however, this analysis will not be submitted to NRC until 3 years after COL.
