SUMMARY

This refers to letter received April 1, 2011 (with attachments) and the phone conversation between Charles Denny and Mike Herr on June 14, 2011.

During our review of your letter received April 1, 2001 (with attachments), we noted that your request to appoint a new Radiation Safety Officer was not signed as required by 10 CFR 30.51(c)(1). Please resubmit a written, dated, and signed request to appoint a new RSO.

Due to an NRC policy change, you will not be able to change and name your RSO internally previously allowed. NRC must do that for you via the amendment process.

We also require that proposed RSO's acknowledge their assignment to the position of RSO and provide a statement that they understand the duties and responsibilities of the position. Please provide a written, dated and signed statement from the proposed RSO that s/he accepts the position as RSO and that s/he understands the duties and responsibilities associated with the RSO position.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.

Upon receipt of your response we will resume our review, Address your written response to my attention at the above address and please be sure to reference Control No. 574830 to facilitate proper handling in our office. As a reminder, please provide the information requested in writing, accompanied by a transmittal letter appropriately dated and signed by a senior management official.

Please submit the requested information within 7 calendar days (by June 21, 2011) by referencing control number **574830** to facilitate proper handling. Upon receipt of your response we will resume our review. Address your written response to my attention at the above address.


