SUMMARY

We have conducted a preliminary review your license amendment request and find that we are unable to continue this action until we have received information regarding the following:

1. What is the nature of the licensing action requested for the Carondelet Cardiology Services, License No. 24-32245-01? Our original understanding was that this was a termination. However, the amendment request was silent as to the status of the Lee's Summit and the Blue Springs sites listed on the Carondelet Drive license. Please indicate their status.
RESPONSE: The contact person indicated, via phone conversation proceeding on June 1, 2011, that the request was limited to moving only the Kansas City location to the St. Joseph license. The Carondelet Cardiology license should be amended accordingly. No additional response is required.
2. For any sources transferred from the Kansas City location, please submit the most recent leak test records for any sources transferred from the licensee, along with relevant area surveys.
RESPONSE The contact person indicated, via phone conversation proceeding on June 1, 2011, that no sources would be transferred from the Kansas City site. No further action is required.
3. For Transfers of Control, the Transferee and the Transferor must provide the information indicated in NUREG 1556, Volume 9, Revision 2, including a confirmation that all records concerning the safe and effective decommissioning of the location of use being transferred will be transferred from Carondelet Cardiology Services, License No. 24-32245-01, to St. Joseph Health Center.
RESPONSE: The contact person instructed the licensee to submit the relevant confirmation regarding records. The commitments were submitted via letter dated June 1, 2011, and were received via FedEx on June 6, 2011. No further action is required.
