Dear Mr. Harden:

On July 21, 2011, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Beaver Valley Power Station (BVPS). The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed inspection report documents the inspection results, which were discussed on July 21, 2011, with Mr. David Huff, Director Site Maintenance, and other members of your staff.

The inspection examined activities conducted under your licenses as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your licenses. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

This report documents two findings of very low security significance (i.e., Green as determined by the Baseline Security Significance Determination Process). The deficiencies were promptly corrected or compensated for, and the plant was in compliance with applicable physical protection and security requirements within the scope of this inspection before the inspectors left the site.

The findings had cross-cutting aspects in the area of human performance because the licensee failed to provide accurate up-to-date procedures [H.2(c)] and failed to effectively communicate expectations regarding procedural compliance [H.4(b)]. If you disagree with the cross-cutting aspects assigned to any finding in this report, you should provide a response within 30 days of the date of this inspection report, with the basis for your disagreement, to the Regional Administrator, Region I, and the NRC resident inspectors at the BVPS.

Additionally, a licensee identified violation which was determined to be of very low security significance is listed in this report. However, because of the very low security significance and because they are entered into your corrective action program, the NRC is treating these
